

## **Minutes of BruNK Meeting June 13<sup>th</sup> 2005**

**Minutes of AGM and April 12<sup>th</sup> meeting approved.**

### **Agenda**

#### **Feedback from AGM:**

It was agreed that in future the AGM would be held in April or certainly after BST.

The saga continues with the Building society and it was agreed that the money would be transferred to another bank.

#### **Core Scheme 4 & Victoria Road Bus Layover, Core Scheme 5:**

The bus layover is to be an extension of Core Scheme 4. It involves the formal siting of the long distance coach park at the Four Lamps end of Victoria Avenue. There will be space for 2 coaches, 50 coaches a day and 100 movements as they arrive and depart. There will also be a taxi rank for 3 taxis and a kiosk for coach drivers. There will be a 10-20% increase in bus use alone.

Core Scheme 5 appears to have been put back. The committee speculate that the council is in the thrall of the bus companies re determining the details and timing of the core scheme.

There was great concern that residents who will be most affected by the plans have still to be informed of the consultation process and in particular the exhibitions last week and this.

**Wendy** to write a leaflet to be distributed immediately, to alert residents to the proposals. She will also to write to Colin Rosensteil.

**Charlotte** will write to Brian Stinton on behalf of the residents association and send copies to Joye Rosensteil and Mick McGuire.

At the time of writing these there have already been developments from this correspondence.

### **Trees on Salmon Lane/Grafton Car Park**

Despite assertions to the contrary the consultation process turned out to be a done deal. Residents, however, have delayed the removal of the trees and are getting an independent survey.

Worst case: trees are taken down and hoardings put up for 18 months followed by trees in pots.

Best case: trees not removed.

It would be possible, if necessary, for the residents association to get a grant to contribute to the cost of the protest.

### **Denmore Lodge**

It has been sold but no details yet.

### **MSC – Lights at MSH, boats, tents,**

Dundy has written to MSH and received a reply, which indicates that MSH has no regard for the problem. They are, however, proposing to put ground lights in. It was agreed that this would be okay if the offending lights are removed.

No feedback yet from boat survey.
