**1. 1. Minutes of Last Meeting**

**2. Core Scheme 5**

Cambridge City Council seems to have forgotten about the new weight limit and the pedestrian crossing on Maid's Causeway.

The committee expressed disappointment at the lack of action on these proposals which were made in July. This has become a low priority for the Council and with the focus on development in the City the committee believes that Maid's Causeway will become a 'bus highway' to cope. This will make a crossing even more important. Our local councilors have not helped.

**3. Midsummer Common Trees**

#### **5. Parking**

#### **6. Any Other Business**

There is £550.03 in the bank after paying for flyers.

Church hall should be booked for AGM in April.

At the next meeting it was agreed the committee should consider how to involve the community more. Jesus Green Association had around 30 attendees at their AGM.

The beer festival is to be moved to the other side of Jesus Green next to Victoria Avenue.
